Just A Quick Note

Maintenance

- According to our covenants and bylaws all lots must be maintained in high standards so as not to detract from the subdivision as a whole. If your lawns, trees and/or shrubs need to be trimmed, weeds need to be pulled or sidewalks and curbs need to be power washed, please take time to get those projects done.
- Lots not yet built on must be maintained to the same standards and cleared at least every two years.

Speed Limit

• When driving in the subdivision please observe the posted 20 MPH speed limit. Please remind contractors as well as family and friends of the speed limit and insist they also observe the speed limit when driving in our community.





Detention Pond vs Retention Pond

Detention ponds serve to hold off storm water to prevent flooding. It's a man-made reservoir that holds the runoff so we don't have overflow onto our properties and public roads. Also a detention pond is typically dry between rain events.

Retention ponds are permanent pools of standing water, that creates a pond environment and are a man-made reservoir too. They also slow the flow of runoff so water can be stored during drier periods.

The Villa Vizcaya community has a detention pond, which is maintained by Santa Rosa County.
